**TRUSTEE'S REPORT**Dr. Steven Siegel

As I complete my ninth and final year as MASO Trustee and will soon transition from AAO President-elect to President, I reflect on the events within our association and

profession that have transpired during my term of service on the Board of Trustees.

One of the most crucial functions of the Board of Trustees is to hire and oversee the performance of the AAO CEO. As a junior Trustee we conducted a CEO search and were fortunate to hire Ms. Lynne Thomas Gordon. Lynne had vast experience in the healthcare space and was highly regarded as a leader in the association management world. Ms. Gordon reorganized our organization and filled many senior positions with highly

qualified and knowledgeable team leaders. As a result of her effort, we are now a more effective and professionally managed association. Upon Ms. Gordon's retirement and after an outside consultant facilitated search, the Board voted to hire Mr. Trey Lawrence, our VP, General Counsel, Legal & Advocacy, as our new CEO. Mr. Lawrence has seamlessly continued the excellent management of our team and the advancement of our strategic plan.

One pivotal development within our profession was the introduction of direct-to-consumer aligner products. The Board, early on, took a courageous stance and assertive approach to protect the public from potential health and safety concerns from any orthodontic treatment that is not doctor directed, advocating that safeguards be put in place to require the involvement of licensed dentists or orthodontists in treatment. We, as dentists and orthodontists, would not move

teeth without first doing a clinical exam and radiographic evaluation to ensure that there were no pre-existing dental disease or conditions that could exacerbate or lead to dental health issues or a poor treatment outcome. We, as highly skilled professionals, know that teeth do not always move as planned on a computer and there may often be unexpected occlusal changes. We know that treatment must be adequately monitored and treatment mechanics or even a treatment plan may need to be altered due to unexpected treatment responses. The question was, how do we educate and inform the public, legislators, State Dental Boards, regulatory agencies, and others about the potential harm to the public that may occur from DTC orthodontic treatment if that treatment is not directed or overseen by a licensed dentist or orthodontist? Fortunately, we have in place a robust advocatory team and Consumer Awareness Program. Through the effort of the AAO and our members, we were effective in getting our message out. I wonder if not for the AAO, who would have been there to speak on behalf of public health and safety on this critical issue?

I recall, perhaps twenty years ago, when I first became involved in AAO advocacy, how unbalanced our AAOPAC giving plan was. Many years ago, one of our top legislative priorities was for the repeal of the estate tax, which in our printed material was referred to as the "death tax." It was not much fun visiting with some of my Maryland legislators in Washington, D.C. with this as part of our legislative agenda. Frankly, I was reluctant to contribute to our AAOPAC. Over the years, I advocated for a change in our AAOPAC structure and focus. With the hiring of Nathan Mick, our VP of Advocacy, and the team he has put together, I am pleased to report that we now have a balanced giving plan. Our legislative priorities are now in line with the needs of our members; reduction of student loan debt, consumer health and safety issues related to Direct-to-Consumer orthodontic treatment, increasing access to, and the affordability of orthodontic care, and issues important to us as business owners.

We are in the process of building a National Advocacy Network (NAN) so that we can continue to stay well informed and be proactive on legislative and regulatory issues that affect our profession, practices, and public health and safety. We now focus our advocacy effort more on the state and local levels, knowing that legislation and regulations at the local level can have a profound effect on our practices and profession. I now gladly give the maximum allowable AAOPAC contribution each year and hope that you will consider giving generously to our PAC.

In 2018, I was asked by the AAO President to chair a CODA Review Committee which consisted of eight orthodontic educators including a representative from the American Board of Orthodontics. Our task was to review the Accreditation Standards for Advanced Dental Education Programs in Orthodontics and Dentofacial Orthopedics and make any recommendations needed to improve and strengthen the standards. Our committee made a series of recommendations which were presented to a large group of educators through

presentations at the Society of Educators meeting and ABO Educators Symposium. We were able to obtain approval from the Board of Trustees and the recommendations were made to CODA. After several years, many of the recommendations were adopted into the standards. These included, for the first time, quantitative numbers for faculty to resident ratios for each program as well as for clinic coverage. These changes were needed to ensure that our orthodontic residents continue to receive the highest quality orthodontic education. The AAO, through its Council on Education continues to monitor and evaluate the accreditation standards and site visitation process.

I am proud of the actions of the Board and House of Delegates in creating the Special Committee on Women Orthodontists and Special Committee for Inclusion and Engagement. The demographics of our residents have changed and are much more diverse than in past years and will translate to a demographic change in our membership over time. We want to ensure that all our members feel welcome, engaged, have pathways to leadership and speaking opportunities, and that we are responsive to the needs of all our members.

The Board of Trustees, with the approval of the House of Delegates, created up to three Trustee at-large positions on the Board. The purpose was to add diversity and expertise to the Board. The Trustees-at-large have the same responsibilities and voting privilege as constituent elected Trustees, with a term of two or three years. This has been a wonderful addition and our first six Trustees at-large have added knowledge and perspective to the Board, which I find exciting and invaluable.

The Covid 19 pandemic created unique and unprecedented challenges for all of us and our association as well. I was a member of the AAO Covid 19 Task Force which included members with expertise in infectious diseases, infection control and office design. A resource page was created on our member website to provide critical information and resources during this stressful time. Lines of communication with regulatory agencies like CDC and OSHA were established to help ensure that through the AAO our members had a voice in policy discussions.

Lastly, I would like to mention the AAO Tech Transformation. In 2024 the AAO House of Delegates approved a Board resolution to create a 3-million-dollar technological transformation fund. This fund is needed to modernize and integrate the AAO's various management systems, marketing platform and member website. Mr. Rez Garrow was recruited to serve as the AAO Director of Information Management Solutions and oversee this multi-year project. Mr. Garrow recently provided an update on the considerable progress made in a presentation to the Board. He highlighted active advancements across all workstreams, supported by a dedicated project manager and a structured governance framework operating in 90-day increments. Key accomplishments include the completion of the ecosystem strategy and future state blueprint, IT policy updates with gap analysis, and the identification and prioritization of over 400 business and system requirements. Looking ahead, the first quarter of the new year will focus on selecting a common data platform, which will serve as the

foundation for improved data organization, migration, and analytics capabilities. This is a comprehensive project that will have an impact on all AAO departments and will allow the association and our members to interact more effectively.

As meaningful and important as the work I have done as a Board member is, it is the friendship with my fellow leaders that has been most rewarding. The Board members have been extraordinary in their commitment to our profession, but beyond that we enormously enjoy the comradery and social interaction that occurs outside of the boardroom. ## **A Trifecta For Our Educators**

The first "win" occurred when our leaders invested in the health of our profession with the formation of the American Association of Orthodontics Foundation (AAOF). The result, over decades, has been over \$15 million dollars committed to the advance of the science of orthodontics and the important financial support of our educators. In spite of transformative technologies and treatment modalities resulting in existential threats, the orthodontic specialty is stronger than ever. The basic science and clinical research supported by grants from AAOF contributed to the evidence-based implementation of these treatment modalities that have enhanced our treatment outcomes.

The second "win" for the future of orthodontic education occurred when the MASO delegation crafted a resolution describing the "Full time Faculty Fellowship Program", presented it to the AAO house of delegates, and successfully championed its adoption. This program has been designed to lessen the disparity between private practice income and that of a junior faculty member. By all measures the retention of MASO junior faculty members has been enhanced as a result of these grants which supplemented university incomes. In recognition of the importance of this program, the AAO HOD recently

challenged the AAOF to launch a campaign dedicated to raising 1.8m that the AAO will match, dollar for dollar, to permanently implement the Full-Time Faculty Fellowship program. This dedicated fund of \$3.2 million will permit the funding of three, two-year, \$30,000 fellowships to supplement the salaries of junior faculty members.

The third "win" ensuring the future of our profession was the formation of the Society of Orthodontic Educators (SOE). Bringing together our educators to brainstorm and collaborate on education issues at AAO Annual Session has had a tangible impact on the quality of orthodontic education. Since its inception, SOE provided valuable input to CODA resulting in a revision of orthodontic standards. It helped develop a closer working relationship of educators and the ABO, resulting in a growing number of orthodontists gaining ABO certification. Recently, SOE members developed webinars titled "Integrating Clinical Informatics and Standards", another example of a small step forward to improve the quality of education.

In conclusion, our orthodontic volunteers have successfully invested in the "orthodontic education 401K" of our profession and are reaping the benefits of these wise decisions.

### ORTHODONTIC TREATMENT FOR A COMPROMISED 69-YEAR-OLD FEMALE DENTITION

### Abstract

Orthodontic treatment of the elderly dentition creates real challenges and the need to establish realistic patient outcome expectations. This case report describes the treatment of a 69-year-old female dentition with a bilateral Angle Class II malocclusion, severe maxillary and mandibular crowding, gingival and periodontal recession and a poor treatment prognosis. The patient was told by other professionals that she would lose all of her maxillary and mandibular anterior teeth. With low treatment expectations, the patient was treated with maxillary and mandibular fixed appliances, and interdental elastics. Implant/crowns placed years before orthodontic treatment helped treatment goals. Appropriate leveling and alignment of the dentition was obtained with space maintenance for crown reconstruction. There was no tooth loss during treatment and the outcome produced a good long-term prognosis.

### **Main Points**

- Teeth with severe bone loss can be moved and maintained in elderly dentition.
- Extreme dental mobility can occur without adverse consequence during treatment of a compromised dentition

- Dental implants can be used to achieve required maximum anchorage.
- Teeth considered to have a hopeless prognosis can sometimes be saved.

### INTRODUCTION

As the population average life expectancy continues to increase, a greater number of elderly patients present with their natural dentition; however, it is frequently compromised.<sup>1, 2</sup> These conditions present new and complex challenges for dental professionals, especially considering that most patients in this population age want to keep their natural dentition and often reject denture treatment options.<sup>1, 3</sup> To address this situation, a combined orthodontic-restorative treatment approach has been shown to be a comparatively non-invasive way to deliver proper function and improved esthetics while preserving the natural dentition.<sup>4-6</sup>

There are many clinical considerations that need to be addressed to determine the direction and success of the orthodontic approach. These include the status of periodontal attachment, implants previously placed, the need for post-orthodontic dental restorative work, and the patient's mucogingival status. Unfortunately, bone loss and gingival recession are commonly noted in older patients.<sup>7,8</sup> Fundamentally, a minimal amount of healthy alveolar bone must be present to ensure a successful orthodontic outcome. 1, 9, 10 When teeth are proclined beyond optimal inclinations,, soft and hard tissue of appropriate dimensions must be present to avoid an iatrogenic outcome. Since mature adults frequently have dento-facial asymmetries, vertical and horizontal tooth movements must respect the limits of periodontal support. Implant placement for anchorage might be a necessary conditions to achieve the best outcome. 10, 11

Collaborative effort is almost always essential to achieve the necessary treatment objectives, since every case is unique, and requires different areas of expertise.<sup>12, 13</sup> Complex interdisciplinary cases require good judgment on the part of experienced dentists and specialists.<sup>9, 12, 14, 15</sup>

This case report describes the treatment of a 69-year-old patient with compromised dentition using orthodontic conventional braces. It demonstrates how dental midlines, curve of Spee, vertical and horizontal dimensions were corrected. It also discusses dental mobility during and after orthodontic treatment, functional outcomes, esthetic improvement, and long-term prognosis.

### **Diagnosis and Etiology**

A 69-years-old female presented to the University OF Maryland School of Dentistry with a chief complaint of "my teeth are moving more than normal following implant placement, and my dentist said I might lose all my front teeth". The patient had two stable implants although the bone grafting procedure was complicated with calcium intake. The extraoral lateral photographs depict a concave lower facial profile, an obtuse nasolabial angle, and acute mento-labial fold. (Fig. 1) She exhibited passive lip closure and her facial thirds were balanced. There was facial asymmetry in which the right side was slightly longer than the left. Upon clinical examination, bilateral asymptomatic temporomandibular joint clicking was noted. She also reported the presence of controlled celiac disease.

The intraoral images revealed a right-side molar and canine Angle Class I, and left side canine Angle Class II malocclusion. The molar Angle classification was not determined on the left side since there were two implants/crowns in that section of the mandible. The patient had three millimeters of overjet and six millimeters of overbite. Severe maxillary and mandibular crowding was noted; perhaps associated with excessive tightness of the circumoral musculature. The mandibular midline was deviated towards the left side. Generalized extensive gingival recession and dental root exposure, associated with teeth extrusion and lack of bony support

were also recorded. There was anterior tooth mobility, the presence of black triangles between most of the maxillary and mandibular dentition, wear of the incisal edges of all incisors, and staining on most teeth. (Fig. 1)

The panoramic radiograph indicated several missing teeth including all third molars, the upper and lower first premolars, the maxillary left lateral incisor, and the mandibular left second premolar and first molar. (Fig. 2) Implants/crowns were present to replace the maxillary left lateral incisor, the mandibular second premolar and the mandibular first molar. A gold crown on the maxillary left second molar, was over extruded below the occlusal plane. Porcelain crowns were present on the maxillary right and left first molars, the mandibular right and left second molars, as well as on the mandibular right first molar. There was previous endodontic treatment on the maxillary left first molar. The presence of generalized, severe bone loss was noted. Also noted was a radiopaque image between mandibular right canine and second premolar. The lateral cephalometric analysis indicated significantly retroclined maxillary and mandibular incisors, retrusive maxillary and mandibular jaws, reduced lower 1/3 of the face, an impinging deep bite, and increased curve of Spee. (Fig. 3-4) (Table 1)




Figure 3: Initial cephalometric x-ray film




Figure 4: Initial cephalometric x-ray tracing

### **Treatment Objectives**

The treatment objectives were to (1) eliminate maxillary and mandibular crowding, (2) reduce the curve of Spee, reduce overbite, (3) correct the maxillary and mandibular midlines as much as possible, (4) procline maxillary and mandibular incisors, and (5) reduce root exposure/gingival recession resulting in good function and esthetics without need for extraction. Ultimately the goal was to finish treatment while recognizing the need for a realistic instead of an idealistic treatment approach.<sup>16</sup>

### **Treatment Alternatives**

Several treatment alternatives were offered to the patient.

- 1. No orthodontic treatment. She had maintained .ost of her teeth for 69 years, and perhaps with good oral hygiene might be able to maintain them for a considerable period.
- 2. Since the patient already had a few implants placed, and a guarded prognosis for the remaining teeth, the extraction of all teeth with implant supported prosthesis..
- 3. Extraction of all maxillary and mandibular teeth and replacement with full dentures.
- 4. Extraction of the teeth with the worst prognosis and replacement with removable maxillary and mandibular partial dentures.
- 5. Orthodontic aligners to intrude maxillary and mandibular teeth to simplify oral hygiene procedures but with the understanding that the number of aligners would increase treatment time. 6- Comprehensive orthodontic treatment with braces on maxillary and mandibular teeth to resolve most problems found on the diagnostic problem list.

The patient chose alternative number six. However, a statement was inserted on her contract about the potential for losing all maxillary and mandibular anterior teeth during the treatment. She took the risk of treatment since she had been already told that without treatment she could potentially lose all of her teeth.

The incisal edges of maxillary and mandibular central and lateral incisors would need to be restored at the end of treatment. The length of the crown to tooth ratio would not change. Gingival recession and dental root exposure would likely remain at the end of treatment. Black triangles would also likely be present after treatment. The facial asymmetry would remain unchanged and the asymptomatic TMJ clicking would likely be present at the end of treatment. The patient was informed that if pain arose during the orthodontic treatment, she would be referred to a pain clinic, and orthodontic treatment would resume following pain management. Referral to a general dentist for routine dental prophylaxis would be necessary. The radiopaque image between mandibular right canine and second premolar would be followed. She was informed that her teeth could become even more mobile during treatment.

### **Treatment Progress**

At the start of treatment, the gold crown on the maxillary left second molar was banded and brackets were bonded on the remaining teeth. Only one attachment was placed

on the mandibular left posterior teeth since both units were implant/crowns. The maxillary teeth were bonded with American Orthodontic 0.022x0.028 Slot MBT prescription. Porcelain etching material was used to bond on porcelain crowns. Transbond XT® was used as a bonding agent. A maxillary arch wire (0.014 NiTi) was inserted on the first visit, the patient was given dental wax to prevent lip injuries, and oral hygiene instructions were provided.

In the subsequent visit, the mandibular arch was bonded with brackets with the same prescription and a 0.014 NiTi was inserted. On the next visit, mandibular anterior teeth showed significant mobility and the patient was instructed to monitor them for further mobility while the teeth aligned. Patient was reassured that the excessive mobility would decrease after removal of the braces.

The next arch wire was a 0.018 NiTi and the teeth started to show some intrusion; although the mobility remained high. Spaces were still present distal to the canines but alignment of upper and lower teeth steadily improved. The patient reported sleeping with a cotton roll between her teeth to prevent premature contacts. The mandibular 0.016 NiTi was followed by an 0.018 NiTi, while the maxillary arch progressed to a 0.017x0.025 NiTi wire in subsequent visits. At every arch wire appointment, the elastomeric rings had to be removed with the doctor's

fingers holding the teeth inside the alveolus, because of the significant dental mobility. (Fig. 5)

The final working arch wires were maxillary and mandibular .017x.025 SS and .021x.025 SS to complete all leveling and alignment. The alignment continued to progress with noted excessive tooth mobility. The maxillary right second premolar which was the only tooth in contact with the opposing arch. This tooth was intruded along with the maxillary right first molar. (*Fig.* 6)

Additionally, an open coil spring was introduced on the mandibular left side to open space for another implant/crown of mandibular left first premolar area and to help reposition mandibular midline. The maxillary and mandibular incisors were also intruded differentially, since the patient complained of contacting only the front teeth. As more dental units reached contact with the opposing arch, the mobility of teeth reduced. (*Fig. 7*)

The maxillary arch wire was constricted to allow better intercuspation on the left side due to the presence of implants on the mandibular arch. The maxillary incisors were intruded using the maxillary left lateral incisor implant as an anchor unit and power chain was utilized to close remaining spaces. A vertical space was left on the posterior segment to build "higher" crowns in order to restore the vertical dimension of occlusion.

Light force class II elastics (2.5ounce 1/4 inch, 12 hours per day) were used on the right side to improve the antero-posterior relationship and a posterior vertical elastic was also inserted on the right side to help close a posterior open bite.

Coordination with a fixed prosthodontist was necessary so that removal of orthodontic appliances, the polishing of teeth, and the fabrication of two crowns could take place on the same day. Once temporary crowns were made, maxillary and mandibular impressions were taken for the fabrication of Essix® retainers. At a later appointment the patient opted for Vivera® retainers.

All mandibular incisors and canines were then bonded with coaxial 0.0215 arch wire to act as a permanent lingual retainer. Essix® retainers were worn 24/7 for 6-7 months and then reduced to 18-hour wear time. (Fig. 8) The patient was then recalled for retention control and occlusal evaluation. (Fig. 9)

### **Treatment Results**

The major objectives of this treatment were accomplished. The treatment resulted in stable and well-aligned dentition. There was no tooth loss during treatment and the overall prognosis of the dentition was improved. The mandibular left second molar developed

a furcation problem during the retention period, and was extracted one year after treatment. Overall, the patient was extremely pleased with the orthodontic result.

The intraoral photographs show a leveled occlusion and proper alignment of the midlines. Ac close to ideal Class I canine occlusion relationship was achieved. The curve of Spee and the dental vertical dimension on the left side were also improved contributing to significant positive changes to the mucogingival tissues. (*Fig. 8*)

The final radiographs show successful intrusion of maxillary and mandibular incisors, which lessened the appearance of interproximal black triangles. Greater bone support was also evident on panoramic images. (Fig 10) The cephalometric analysis showed desired proclination of maxillary and mandibular incisors, which also improved lip support and esthetics. Cephalometric




Figure 11: Final cephalometric x-ray tracing




Figure 12: Initial and final superimposition.

tracings also indicated clockwise rotation of the mandible, making the chin less prominent. (Fig. 11) The superimposition shows the proclination of maxillary and mandibular incisors and the significant intrusion of mandibular incisors, slight clockwise rotation of the mandible. (Fig. 12)

Lastly, the patient's chief complaint was addressed. The teeth at the end of treatment had minimal mobility. At 6 months retention the dentition was found to be stable and no occlusal adjustment was necessary.

### **DISCUSSION**

The dentition of mature, older patients present with many different factors that can make restoring function and esthetics complex.<sup>1, 3</sup> Teeth may be missing, worn, rotated, mobile, stained, or infected, and bone loss is also a common issue.<sup>1, 3, 7, 8</sup> Additionally, the medical history and systemic conditions can also affect treatment outcomes. When treatment planning for elderly patients with a compromised dentition, all of these factors must be considered not only as potential problems but also when developing solutions.<sup>17</sup>

This particular case was successful despite the multitude of clinical issues which were not ideal. Some of the clinical complicating issues were used as an advantage to resolve the case. The implants served as anchors for the intrusion procedures; which would not have been possible due to the torque that would have been applied to the mobile surrounding teeth. Emphasis on saving natural teeth rather than planning for restoration or extraction was considered in this case. The alveolar bone was adequate for orthodontic movement.

While treating compromised dentitions especially in elderly patients, dentists must realize that a realistic approach must be taken over an idealistic one. Effective communication between different disciplines is essential for successful treatment of these patients.<sup>5,17</sup> The collaboration between the orthodontist, the prosthodontist, and the periodontist facilitated the delivery of crowns necessary to increase the posterior vertical dimension, and the maintenance of a good periodontal condition.

Elderly patients are one of the most underserved populations, and have the highest prevalence of oral disease. <sup>1, 2</sup> They often lack the ability to drive to appointments, may struggle financially, and may be insecure due to inadequate health literacy, <sup>2</sup> It is the responsibility of dental health professionals to reach this population and empower them to be an active proponent of their oral health.

Improving function and esthetics through orthodontics in the aging population is a great alternative to more traditional prosthodontic options. Patients may avoid losing their natural teeth while undergoing realistic noninvasive treatments that do not require surgery. Most importantly these realistic approaches vastly improve this population's quality of life. 16, 18

### CONCLUSIONS

This case report showed how orthodontics can be used as the major treatment approach to elderly patients with compromised dentitions. Patients with considerable alveolar bone loss, gingival recession, and root exposure do not necessarily need extraction of teeth, and instead can be treated with orthodontic intrusion, and orthodontic realignment. Holistic orthodontic treatment, supplemented by prosthodontics and restored function was provided and resulted in a viable treatment of a compromised dentition.

The council members and talented AAO staff have continued the important work of engaging and educating parents and patients, and strengthening the value of

AAO membership. The COC met virtually four times this fiscal year 2025 – July, August, October, and December. Please see below for an update on COC activities and feel free to reach out to me with any questions or ideas.

## CONSUMER AWARENESS PROGRAM (CAP) – FISCAL YEAR 2025

The CAP is the only mass advertising campaign promoting orthodontists as specialists and educating the public to see an orthodontist in person. The CAP program currently focuses on digital marketing, with the goal of driving quality traffic to the consumer website.

FY24 Performance June 1, 2024 – November 2024: (first half of the fiscal year)

- **252M impressions served** This means that CAP ads appear across platforms like Google display, Paid Search on Google and Bing, YouTube online video, Facebook, and Instagram.
- · Over 9.8M video views
- · Nearly 8M ad clicks
- Over 6.8M consumer website page views
- Over 2.2M Find an Orthodontist locator visits

FY25 Consumer Awareness Program highlights:

- 1. The Science of Smiles Campaign: Launched in April 2024 and will continue through FY25. From November 1 December 31, 2024, we will have two ads in rotation: How Much Do Braces Cost (adult, self-purchase) & How Do Braces Work (parent audience). The Science of Smiles campaign positions orthodontists as the ultimate authority through a series of engaging and educational videos highlighting their unique education and training and establishing them as the go-to experts sought after for their exceptional knowledge and skill. This campaign is seeing impressive results on all paid digital channels, with additional episodes scheduled for release throughout the year.
- 2. **Digital Agency:** We continue to optimize our CAP outreach with our digital agency, Steady Rain. They continue to help AAO significantly improve key metrics, with noteworthy year-over-year increases in traffic to the

consumer website, page views, ad clicks, and video views. Despite maintaining flat spending, our cost per user has declined, highlighting the efficiency of our investment. Proper oversight is in place, and AAO Staff monitors the agency dashboard daily, meets with the agency bi-weekly, and provides ongoing reports to COC.

- 3. **Search Engine Optimization (SEO):** This is an ongoing focus throughout FY25. COC continues to enhance and refine landing page content and develop new content for the consumer website to ensure we optimize organic traffic. We continue to attract visitors, especially with Mewing and Fashion Braces-related content. Plus, we are making content updates to better align with AI in organic search and AEO (Answer Engine Optimization), ensuring the AAO is the accurate and reliable authority for search engine queries.
- 4. **2025 PSA Collaboration:** We are partnering with the American Association of Oral and Maxillofacial Surgeons (AAOMS) and the American Academy of Pediatric Dentistry (AAPD) to create a PSA titled *Milestones Met*, *Healthy Teeth Set*. This PSA will stress the importance of seeing the appropriate dental specialist at ages 1, 7, and 15.
- 5. **2025, the 125th Anniversary of the AAO:** From January 1 to December 31, 2025, we will celebrate the AAO's 125th anniversary with various programs, marketing initiatives, and events, honoring our legacy and commitment to excellence.
- 6. **Bullying Bites 2024 Recap:** For the sixth year, the AAO's #BullyingBites campaign coincided with National Bullying Prevention Month. This initiative empowered both members and patients to act by creating awareness and spreading the message of kindness. This year, we leveraged public relations in three local markets El Paso, TX, Ann Arbor, MI, and Portland, ME and garnered over 1.3M viewers through our outreach. Plus, we lit up landmarks around the country, offering additional resources for members, partnered with the AAO Advocacy team, encouraging members to support a bipartisan bill to improve access to mental health resources in schools, and launched a new partnership with Kind Lips lip balm, an organization who also supports anti-bullying efforts.

Onur Kadioglu, ABO Liaison provided us with updates on the ABO Written and Clinical examinations. Dr. Kadioglu reported that 63% of AAO Orthodontists are now board-certified. The 2024 Written Exam was administered in April, with 443 examinees and a 99% pass rate. The next written exam is scheduled for April 9, 2025. Open registration started on November 6, 2024. Residents must have completed 18-months of their program by the Written Exam to be eligible to take

the exam. For questions, please reach out to Nicole Huson at Nicole@AmericanBoardOrtho.com. The February 2024 Scenario-based Exam had a total of 329 orthodontists certified with an 89% pass rate. In 2025, there will be one Scenario-based Exam per year on September 17, 2025. Registration opened on September 18, 2024. For scenario test questions, residency programs should reach out to Kim Koch at Kim@AmericanBoardOrtho.com. Certification Renewal is required to maintain active board certification and may be started no earlier than 36 months prior to expiration.

The council recommended that AAO continue its support of the Full-time Faculty Teaching Fellowship Award Program and other awards to improve faculty retention and decrease the current shortage of orthodontic educators. The COE also recommended support of the donated Orthodontic Services Program.

The next COE virtual meeting will be on January 15, 2025. Among the agenda items, the next chair of the COE will be nominated and voted upon. The next Society of Educators Meeting conference honors Dr. James McNamara and is at the AAO annual meeting in Philadelphia on Thursday, April 24, 2025. Dr. James A. McNamara is the 2025 Honoree and Keynote Speaker. He will present on the topic "Evolution of Contemporary Orthodontic Treatment Options: A 60-year Personal Perspective". It will be a memorable presentation, so please mark your calendars.

I look forward to seeing many of you at the MASO Spring Program on March 7, 2025. The COE is always willing to hear from our members and educators with any suggestions and comments. We are working for you to improve orthodontic education. If you have any topics that you wish to bring to the COE, please feel free to contact me.

2025 has already started with the Council on Government Advocacy (COGA) working hard on behalf of our association. We continue to build on

our 2024 successes and accomplishments with our member advocacy priorities. Our key issues remain as follows: workforce challenges, small business issues, student loan debts along with patient health and safety relating to mail order Orthodontics. We have had many conference calls to nominate and elect a new COGA chair and to finalize

planning for our upcoming joint COGA-AAOPAC boards meeting in Washington, DC which will take place in concert with the AAO's 2025 professional Advocacy Conference (3/11 - 3/12). We will meet for a day and a half prior to the actual start of the meeting. We also met in person back on 8/22- 8/24, 2024 and worked hard on planning and finalizing all preparations for this upcoming Advocacy meeting. This will be one of the most successful meetings to date. I would like us to beat last year's stellar contributions for the 30th anniversary of AAOPAC and to urge you all to make a contribution at AAOPAC.org.

Those dollars are instrumental in helping to fuel our advocacy priorities not only at the federal level but in states across the country.

### COUNCIL ON MEMBERSHIP, ETHICS & JUDICIAL CONCERNS

It was wonderful to see so many of you at our Annual Session in St. Thomas.

Congratulations to Dr. Omid Rajaei and the planning committee for such a successful meeting!

I continue the privilege of representing MASO's members on COMJEC. Our fall meetings were held by Zoom. Dr. Mathew Ng (SWSO) continues as our Council Chair; Dr. Ken Webb (NESO) is now our Trustee Liaison and Mr. Brandon Hackworth is our AAO lead staff member.

Some important updates from our ongoing work:

### **HOD Resolutions**

- COMEJC submitted four resolutions to the 2024 AAO House of Delegates that were adopted and here are their outcomes:
  - 08-24 COMEJC Bylaws Amendment (International Member Eligibility)
    - Result: This removes superfluous and outdated language from Bylaws. International Membership eligibility is not impacted.
  - 09-24 COMEJC Bylaws Amendment (Retired Membership Eligibility)

Result: Bylaws now more clearly define what constitutes retired status from the membership standpoint. More specifically, member must have retired from orthodontic practice, teaching and research but are allowed an exception up to 416 hours per year (one day per week) if they teach at an accredited program/dental school and/or provide locum tenens coverage.

- 14-24 COMEJC Establishment of Trial AAO Membership
  Result: The trial membership is being implemented for
  2024-25 to allow eligible orthodontists to join at no
  cost for the first year (constituent/component dues still
  apply).
- 15-24 COMEJC Extension of Pilot for Bulk Membership Dues for International Orthodontic Societies
   Result: A previous pilot program is being extended by one year so the AAO can attempt to negotiate bulk membership dues with select international societies.

### **Membership Trends**

- **Total AAO membership** is now at 18,920, a net decrease of 183 year over year. The primary reason for this comes from International Student Members (-236) and International Members (-125).
- **Total member retention** decreased from 93.9% in 2023 to 93.6% in 2024. This is primarily driven by retention decreases among Active Members, Student Members, International Members and International Student Members.

### **AAO COUNCIL REPORTS**

• Current **U.S. market** share is calculated as 9,702 AAO members out of a total population of 11,302 orthodontists, or 85.8% as of May 31, 2024. This is a decrease from 86.4% in 2023.

### Other Initiatives

- Upon referral from the Board of Trustees in February 2024, COMEJC reviewed the AAO's graduated dues scale available to new Active Members in their first four years. Following review of data and consultation with the Council on New and Younger Members, COMEJC reported to the Board in August 2024 that it does not recommend any changes to the dues scale at this time.
- COMEJC has formed an International Strategy Subcommittee to review the results of an International Member survey conducted in spring 2024. COMEJC will be using the survey data to consider changes to the AAO's international strategy, which will be recommended to the Board of Trustees.
- COMEJC continues to oversee the facilitation of the AAO's
  Resident Vitals and Financial Management for Residents
  presentations that are offered to residency programs
  annually (either in-person or virtually). Invitations were
  sent to orthodontic program chairs and directors to sign up
  for the presentations in August 2024. As approved by the
  Board of Trustees, the AAO will be utilizing six designated
  presenters to residency programs that sign up to host
  Resident Vitals. Presentations may also be requested at
  https://www2.aaoinfo.org/programs-for-residentsand-educators/orthodontic-program-presentations/.

I look forward to the next in-person COMEJC meeting on January 10, 2025. As always, when contemplating the initiatives and impact this Council can have, I think of what is in the best interest for the members of MASO, including our residents. COUNCIL ON SCIENTIFIC AFFAIRS

The AAO COUNCIL ON SCIENTIFIC AFFAIRS (COSA) has been diligently working on scientific matters on behalf of the AAO in preparation for the 2025 Annual AAO Meeting in Philadelphia.

The following applications were received by COSA.:

- Hellman, Sicher and Graber (HSG) awards: 28 excellent basic science, translational and clinical papers were received. The recipients for the awards will be announced in February.
- Oral Research: 84 received 19 accepted and six were selected to send a 2-minutes video, for selection of 2 research projects to be presented during the SOE meeting.
- Table Clinic: 41 received and 21 accepted to present at the AAO
- **Abstracts/e-Poster:** 304 e-posters received (there will be several more that were Oral Research and Table Clinic that were also accepted to be presented as e-poster)
- **Dr. William R. Proffit Resident Scholar Award program** application deadline is February 3, 2025 at 6:00pm.

COSA was also asked to revise a paper about microplastics published in the JWFO in November, and the members are working to provide a comprehensive report on the subject. There is concern of the authorities and the population about microplastic particles broken down from aligners and

its influences in the body. COSA and the AAO BOT shall be producing a summary of the findings soon.

All Council and Committee chairs, trustee liaisons and staff liaisons, and BOT members met on a Zoom call on December 11 to discuss possibilities of working on common projects. The meeting was truly enlightening and inspirational, and we anticipate that many projects beneficial to the AAO will result from this meeting.

### I. MEETINGS

COSA is scheduled to meet on January 10, 2025 on a ZOOM call in preparation for COSA activities at Annual Session.

**II. REFERRALS BY THE 2024 HOUSE OF DELEGATES**There were no HOD recommendations sent to COSA.

### **Term of Office:**

On an annual basis, and prior to constituent organization annual meetings, staff in the AAO Executive Office will provide council/committee chairs, Trustee liaisons and staff liaisons a schedule of council/committee members who are scheduled to renew their terms at the beginning of the next council/committee year. The council/committee chair should then coordinate with the renewing members to determine whether they have interest in renewing their terms, as opposed to automatically renewing them at the end of the year. In the event a committee member does not wish to renew their term, the committee should begin to identify a replacement.



AAO PAC UPDATE
Dr. Doug Harte

As 2024 ended with the successful 30th Anniversary of AAOPAC, we look forward to celebrating 125 years of AAO in 2025. New

changes are on the horizon as well as continued improvements are coming in this year. There has been a big change in the federal political landscape this year. We have a new (and former) President in office as well as a New 119th Congress. The Republican party will have control of both houses of congress. But as we have seen, their majorities are slim and will provide opportunities for compromise and as such will be good for us and our AAO priorities.

We continue to work with Cozen O'Connor as our lobby group and they help us to provide key contacts in Washington as well as to help guide us in our annual giving plan. It was noted that a divided government could be advantageous for small businesses due to less drastic policy changes.

Key legislative priorities include:

- The REDI Act: This bill in the last congress was supported by 66 House and 16 Senate co-sponsors. The Act would allow deferment of student loan payments for medical and dental interns and residents, improving access to care in underserved areas.
- The Oral Health Literacy and Awareness Act: Proposed legislation requiring HRSA to run a public education campaign to boost oral health literacy.
- The Ensuring Lasting Smiles Act (ELSA): This bill, which neared passage in the last congress, would mandate insurance coverage for congenital anomalies and birthdefects. There is urgency for its passage as two co-sponsors are retiring soon.
- The RAISE Act: Supported mainly by Republicans, this act would allow FSA and HSA savings to roll over into the next year.

These priorities will all need to be reintroduced with the new congress but we remain highly optimistic this time around.

The National Advocacy Network (NAN) will continue to expand and evolve to maximize strategic grassroots engagement by AAO Members for policy influence across the United States and Canada.

A large part of our fundraising since 2023 has been in conjunction with MMS company. It has proven to be a good partnership so far with the AAO.

#### Overview

2023 marked the first full year of the MMS and AAOPAC partnership. The goal of 2023 was to jumpstart AAOPAC's fundraising efforts after a few years of minimal member outreach. This effort was extremely successful in rejuvenating AAOPAC's contributor file and helping to deliver record revenue for the PAC.

In 2024, with the AAOPAC back on a firm foundation, the goal was two-fold: maintain the strong participation from a core group of dedicated supporters and invest in generating the 1st time contributors necessary for long-term growth.

As of November 18, 2024, AAOPAC has gained a 50% increase in prior contributor participation, while also generating a 260% increase in first-time contributors over 2023 at this same time.

AAOPAC had outlined four main strategies used to mobilize the grassroots network:

- 1. **Phone 2 Action:** Managed by our federal and state call-to-action consultant, this initiative has been particularly effective in states where advocacy efforts have faced challenges.
- 2. **In-Person Advocacy:** This strategy involves direct engagement by AAO NAN leadership and member advocates with legislators, lawmakers, and government agencies through both in-district and virtual meetings.
- 3. **Digital Advocacy:** In collaboration with the AAO marketing department and consultant Allison Aubuchon, this approach utilizes social media to promote calls to action and advocacy initiatives.
- 4. **AAO In-Person Events:** Events such as the Professional Advocacy Conference, GORP, Constituent meetings, and the AAO Mid-Winter Meeting offer additional platforms to advance advocacy goals

There are significant National priorities for states in the upcoming 2025 legislative sessions. Efforts in states across the country will be focused on teledentistry, workforce, delegation of duties, and dental auxiliaries. We will also be monitoring the licensure compact in states, dental loss ratio legislation, and more. Advocacy initiatives will also continue regarding delegation of duties and dental auxiliary regulations in Ontario.

As we wind down the 30th Anniversary celebration for AAOPAC in 2024, we are excited to jump into the celebration of AAO's 125th Anniversary. We anticipate continued success through storytelling about the AAOPAC, helping to fuel AAO Advocacy success in Washington, DC and states throughout the country. AAO Advocacy will continue to focus on data-driven policy

priorities in Washington, DC, Canada, and across the U.S. at the state level, including workforce training and shortages, small business initiatives, student loan debt, and mail-order patient health and safety concerns.

2025 Professional Advocacy Conference Planning: The 2025 Professional Advocacy Conference will be held March 11-12 at the Capital Hilton in Washington, D.C. Those who have contributed \$250 or more to the AAOPAC since June 1, 2024,

will be first to receive an invitation to attend. In addition, people giving to the PAC will be able to enjoy the luxuries of the AAOPAC lounge in Philadelphia at the Annual Session. I look forward to seeing you there. Remember that our association is only as strong as its members and their support. Please don't forget to make your contribution this year. AAOPAC.ORG Your important donations help drive our legislative agenda and protect the profession and our patients.

The ABO is committed to upholding our mission to elevate the quality of orthodontic care for the public by promoting excellence through certification, education, and professional collaboration.

### **ABO Yearly Update**

The ABO is proud to announce that 63% of AAO orthodontists are now board certified.

### **Written Examination Update:**

• The 2024 ABO Written Examination was administered to 443 examinees on April 2, at Pearson Vue Testing Centers in the United States and Canada. The examination had a 99% pass rate.

The next Written Examination is scheduled for April 9, 2025, online registration is now open as of November 6, 2024. Applicants must have graduated or enrolled in an advanced specialty education program in orthodontics and dentofacial orthopedics in the United States or Canada, accredited by CODA. Orthodontic residents must have completed 18 months of their program by the Written Examination date to be eligible to take the exam.

### Scenario-based Clinical Examination Update:

• The ABO February 2024 Scenario-based Clinical Examination was conducted February 22-23 at Pearson-Vue Testing Centers Worldwide. 329 orthodontists were certified during the 1st and 2nd Quarters of 2024, including the February examination, which had an 89% pass rate. In addition, 21 orthodontists completed their 10-year certification renewal requirements. Please visit the ABO website for a complete listing of names by constituency for this period.

The ABO September 2024 Clinical Examination was held on September 17 at Pearson-Vue Testing Centers Worldwide.

Beginning in 2025, the ABO will transition to offering one Scenario-based Clinical Examination per year, to be held in the fall. The scheduled date for the 2025 examination is September 17. Online registration is scheduled to open on September 18, 2024.

An orthodontist must first complete the ABO Written Examination before taking the Scenario-based Clinical Examination. Preparation materials for the examination, including study guides and sample cases, along with how to register are located on the ABO website.

### **Certification Renewal Examination:**

• Certification Renewal is required every 10 years to maintain an active board certification status and may be started no earlier than 36 months before the expiration date printed on the individual's certificate. For individuals whose board certification is set to expire within the next 3 years, communications are distributed throughout the year as a reminder to recertify. There are two options to complete the examination, which include one online Board Case Examination or a Mail-In Case Report Examination, both of which also require the completion of continuing education credits from online AJODO-selected articles. Please visit the ABO website for materials to help you prepare for the examination.

### **Educational Update:**

- The ABO Educators Symposium will be held in St. Louis, MO on Saturday, February 22, 2025, with a dinner the prior evening. Invitations for the event have been distributed. **Research** – with presentations to our hospital community in April 2025:

Class of 2025 - **Dr. Jessica Azer** is investigating whether congenitally missing third molars lead to delayed development or eruption of associated second molars using patients from our clinic and a faculty private practice.

**Dr. Alison Novakovic** is evaluating coffee stain removal from Invisalign trays using four commonly used cleaning agents using both computer-based evaluation as well as indirect clinical evaluations by orthodontists.

**Dr. Hannah Yu** is evaluating the relationship between mandibular skeletal asymmetries and Class II subdivision malocclusion using CBCTs.

Class of 2026 – in progress with presentation to our hospital community in April 2026:

**Dr. Ana Maria Male** is investigating the width of maxillary central incisors and their impact on the necessity for extractions and treatment outcomes in patients in our orthodontic residency program.
